## OBOA Report from Phil Seyboldt . . . . . . . . . . . April 20, 2007

The following are my notes from the April 20th OBOA Board Meeting held at the Ohio Code Academy at the Quest Conference Center on Polaris Parkway in Columbus:

- 1. The Ohio Code Academy was held this week at the Quest Conference Center. This location has become very popular due to its large, comfortable rooms and convenient parking facilities. Approximately 90 students attended this session. The BBS reported that the backlog of students from the last year has been caught up, now, so that if anyone wants to attend the Academy for continuing education or for other, non-required reasons, you can now call the BBS offices to make those arrangements. There is still no charge for attending the Academy, but your room and board are not covered. The next session of the Ohio Code Academy will not be until September or October.
- 2. OBOA is forming an AD Hoc committee to discuss the use of the State 3% and 1% monies with the Board of Building Standards not only for an expanded educational program, but also for attendance at ICC code hearings. The committee will include thre (3) members of the executive board and two (2) past presidents. Reports on their actions or progress will be made as they become available.
- 3. For those who have not already heard, Billy Phillips will assume his new duties on May 1st as the Executive Secretary of the Board of Building Standards, succeeding John Brant who will be retiring. Good luck to Billy in his new position. John has indicated that he may still be available on some irregular basis to teach some of the classes that he was famous for. More will follow on that subject as it becomes available.
- 4. The ICC Final Action Code Hearings are being held this month in Rochester, New York. Rochester is only a 3 to 4-hour drive from our area, and this is a good opportunity for Cleveland building officials to take part in the code change process. - 5. The Toledo Joint Conference committee reported that their planning is going well. The next Joint Conference scheduled for Toledo will be held on February 10th, 11th and 12th, 2008. They have reserved the facility and will be making information available as it develops.
- 6. Billy Phillips reported that there will be several mandatory classes arranged for the remainder of 2007. The first class, tentatively scheduled for the month of June, will be an update on both the 2007 OBC and the new Energy Code. Other class topics being scheduled for later in the year will include the Fuel Gas Piping requirements and the update to the 2008 National Electrical Code that will go into effect January 1st of 2008. Billy also reported that the preparations for the effective date of the Residential Code of Ohio at the end of May have gone smoothly, with numerous individuals and departments becoming certified. More on the residential certifications will be on the BBS website.
