OBOA Report from Phil Seyboldt ...

The following are my notes from the Thursday, December 13th OBOA meeting held at the BBS Offices in Reynoldsburg:

- 1. As I have written in previous notes, the education of code officials is one of the foremost missions of both OBOA and BOCONEO. If education is most important, following close behind that mission is that of helping our members get certified in whatever ways that are available to us. OBOA put its best foot forward this week when Billy Phillips of the BBS distributed through OBOA to the Regional Chapters sets of training manuals and code books that our membership can use to prepare themselves for certification exams. If anyone has ever had to go out and buy books with which to study for exams, you would see immediately that they can be very expensive. ACI-318, for example, which contains the requirements for Structural Concrete, costs \$140 by itself, and that is only one of many books that is required to take the tests for BI certification. BOCONEO now owns 4 sets of these code books, standards and study manuals that are available for borrowing. Ray Sack of Wickliffe is our new Librarian (440-943-7115) and the procedures will be published on the website soon. I hope that our membership makes good use of these books, and take the time to thank Billy if you see him. He is a good friend of us all at the BBS.
- **2.** Time has nearly run out for making your arrangements for the 2008 Joint Conference in Toledo. The forms are on the web at www.ncoboa.org. There are many offerings for fire inspectors this year also, so invite your fire inspectors to the conference as well. It's going to be a great time.
- **3.** The report on the Residential Code of Ohio included a few items of interest. The proposal from OBOA to take the maximum size of an accessory building requiring frost-depth footings down to 120 square feet has been defeated and withdrawn. The current maximum size of 400 square feet will remain at least for now. The requirement for the 7-years of experience for residential plumbing inspectors was not voted on and was tabled until another meeting. The Board also ruled that the effective dates for both the 2006 IECC (Energy Code) and the 2008 NEC will be January 1, 2008. Drawings accepted for review after that date must conform to the new requirements. The BBS also reported that the amount of money taken in during the second half of 2007 from the 1% fee amounted to about \$134,000. There were many factors that contributed to the relatively low number, not the least of which is the terrible housing market. We will monitor that number in 2008.
- **4.** The ICC Chapter Rewards Program was discussed briefly. All ICC Chapters, including BOCONEO, get certain benefits for generally being good at what we do. We will receive additional free ICC classes for our Joint Conference in 2009 as well as some free registrations to the ICC code hearings.
- **5.** Roy Baver made a short report on the Fire Service Ad Hoc Committee that was recently convened. The purpose of this committee, made up of representatives of the Fire Marshal's office, the BBS, the Regional Chapters and the Ohio Fire Chief's Assn, is to foster cooperation between the building and fire services. An interesting observation brought to light is that while Building Officials are generally regulated by the BBS and can be disciplined by the BBS for improper use of authority, the Fire Chiefs in Ohio do not answer to the State Fire Marshal, nor does the Fire Marshal have any regulatory authority over them. They can pretty much do as they please in spite of what the Fire Marshal says. That is why it is important to cultivate a relationship between the building and fire departments in each of our local jurisdictions. Good luck to the effort at the State level.
- **6.** OBOA has purchased the rights on behalf of all of the Regional Chapters to advertise our education program as AIA-Approved. Our classes, which are all approved anyway by the OBBS, were always acceptable to the Ohio Board of Examiners for Architects, but now they will also receive credit toward their National AIA license. This is just one more reason among many for architects that work in our area to join BOCONEO and enjoy the benefits thereof. Take the opportunity whenever possible to invite the design professionals with which you work to join our organization.
- **7.** A long discussion took place regarding the efforts of the Board of Building Standards to promote and clarify Section 1704 of the OBC regarding Special Inspections. The consensus was that it is the duty of the design professional on any particular project to specify the requirement for special inspectors for structural steel, poured-in-place concrete, EIFS systems, and a host of other things, as well as to specify the details of what inspectors should be looking for. It is the Plans Examiner's duty, however, to check the specifications for these arrangements, to insure that the necessary inspections have been required. The Building Official must then review the credentials of the special inspectors in question, and review the results of the inspections. BOCONEO will plan a class during 2008 on special inspections.
- **8.** The Ohio Building Code Academy went well during December, with 80 out of a possible 127 individuals attending the academy. The most common complaint among attendees at the academy we are told is that it is a "boot camp" mentality. Billy explained that the academy is intense in its offerings as much as to see if the attendees are ready to be inspectors as it is to teach them something. It may be said that individuals that find the academy overwhelming in its subject matter should probably not be there at all. This is evidenced by the fact that one cannot really fail the academy, but can only be awarded extra studies in areas where they are found to be lacking in necessary background. At any rate, the academy is getting national attention, with several states planning to emulate it in some way.
