Important Note:

At its meeting on Friday, December 12th, 2009, the Board of Building Standards adopted the proposed rule changes that were part of Amendments Group 6 (proposed changes to the residential code). The rules have been assigned an effective date of January 1st, 2009. They include updating the RCO to the 2006 version of the IECC, with a change to RCO Chapter 11 to give another energy compliance option, as well as an update to the 2008 NEC.


Having now completed the ORC 119 rule adoption process, **as of January** 1st, 2009, the 2008 NEC and the 2006 IRC-based RCO Chapter 11 will be effective for all 1-, 2-, and 3family dwellings submitted for plan examination and approval.
