Our last meeting of the early-summer season is already upon us, scheduled for Wednesday, June 17th. On that date we will start at 9:00 in the morning by hosting the monthly meeting of the directors of the Ohio Building Officials Association (OBOA). I encourage everyone that can get away from the office for a couple of extra hours to come and see what happens at our monthly meetings. You will hear reports on all of the various committees that exist, as well as a good BBS and ICC report. One hour of continuing education is available for attending the OBOA meeting. In the afternoon Steve Regoli of the BBS staff is giving a 2-hour presentation on the newest version of Chapter 1- Administration of the OBC. The same text will soon be used for Chapter 1 of the RCO, so come and listen to what the BBS has to offer. Both of these classes are approved across the board for all certifications. Be sure to RSVP by Fax OR via the internet, as this class is sure to be a record-breaker for attendance. As an added bonus for the June meeting, the Executive Committee has arranged a picnic luncheon for all of our members. Following the morning OBOA meeting we will adjourn to the picnic pavilion for our picnic lunch fare, followed by Steve's class back in the Civic Center at 1:00. Let me remind everyone once again to park in the rear-most rows of the parking lot farthest away from the Civic Center itself. The Civic Center staff has remarked that the seniors that use the center at the same time as our meetings have to walk much too far to the building as the result of our parking arrangements. It is important to us to keep that staff happy if we are to continue to be welcomed at the Civic Center. Thanks for your cooperation with that detail. Pray for nice weather on that day and come and enjoy what your organization has to offer.

For those who were not present at the May meeting, here is the latest on the Round table classes. The Plumbing Round table is back on beginning is September, and will be held in one of the large meeting rooms in the adjacent Independence Library. To find the class, park in the Civic Center lot just as you would for the regular meeting (in the rear two rows), and then come in the front door of the Civic Center. Walk straight through and out the back door of the Civic Center toward the rear of the Library. Follow the signs to the Plumbing Class. The class begins at 10:15, with the sign-in sheets being picked up at 10:30, so be on time if you plan to attend. The class is a 1-hour class. At the same time, in our regular meeting room, beginning in September, we will also hold a monthly Electrical Round Table discussion. Just as with the Plumbing, the class will be approved for 1-hour of credit and begin at 10:15. If you come in at the regular time for the normal lunch-meeting, please be considerate if the electrical discussion is still in progress and try to hold down discussions and conversations until the class is finished. Please note for both of these round table discussions that there will be NO CLASS in June. These two new offerings will increase the number of education hours offered by BOCONEO to nearly 40 for the year, giving you the best value for your dues dollars as possible.

Attendance at the Academy is free except for providing your own food and lodging.


