ICC Code Hearings

BOCONEO and OBOA have financial assistance available to all BOCONEO members in the form of supplement funding grants for your attendance at the ICC Code Development Hearings and Annual Conference this Fall, October 24 through November 11, 2009.

Reinbursement will be \$150.00 per day for each day that one attends either the business meeting or the code hearings. The reimbursement would go either to the jurisdiction if it funded the trip, or, to the individual if there was no public money involved.

No one would be eligible for reimbursement for the same expense by both OBOA and BOCONEO. There is no reimbursement for alcoholic beverages. All receipts must be received by November 30, 2009, no exceptions.
