### Code Development Hearings

I had the opportunity to attend the 2010 Final Code Development Hearings in Dallas, Texas in May. My attendance was made possible through a scholarship offered by the International Code Council Foundation (ICCF). This is the first year that this organization funded expenses for individuals to attend the code hearings. Through the foundation, it was an attempt to get individuals to the code hearings who otherwise could not attend due to financial cutbacks occurring in Building Departments across the country. It is an important part of our profession to be involved in the decision making process of proposed changes to the codes. Attendance at these hearings gives the code enforcement individuals an opportunity to voice your concerns or support of a code change and the ability to vote on these changes. We have the choice just to enforce the codes as they are adopted or we have the ability to make changes that affect the way we perform our job in the enforcement of the building codes.

The Final Code Development Hearings in Dallas focused on the changes that will become part of the 2012 International Code Series. In an effort to cut down on the length of time the hearings typically take (2 ½ weeks), this years hearings were split up into Part A which was in Dallas and Part B which will be in conjunction with the Annual Conference in Charlotte, North Carolina at the end of October. During the Part A hearings there were over 650 proposed code changes.

The International Code Council Foundation has indicated that it will offer scholarships for the fall code hearings and conference. Keep an eye on the ICCF website (www2.icc-foundation.org) for further details.

THIS A LETTER WRITTEN BY PHIL SEYBOLDT TO ISO. IT SHOULD BE OF INTEREST TO ALL OUR MEMBERS.

MORE ISO INFORMATION ON PAGE 3.

I received a questionnaire asking for feedback regarding my experience with ISO, and I decided after weeks of thinking about this to write to you with my own comments about the program. I know that this isn't exactly what you had in mind when you sent the form, but I am going to put my thoughts and feelings in writing anyway. First, let me say that my experience with Jim Dudley was positive. Jim has been in my office several times in recent years and is always very professional, friendly and helpful. My comments are directed today at the Building Code Effectiveness Grading Schedule as a program.

My department here in the City of Bedford, Ohio, scored a 3 in the administration of the Non-residential codes, while scoring a 9 in the Residential side of the business. As the Immediate Past President of both the Ohio Building Officials Association and the Northeast Ohio Building Officials Conference you can imagine that I network with other professionals in my line of work rather often. We have talked about this grading system on numerous occasions, and I find that everyone is incredibly frustrated with your system here in Ohio. To get a score of 9 in Ohio, where I believe that we have one of the most progressive and efficient systems of code enforcement in the country, is both embarrassing and demeaning. I am sure that you would have scored Port-o-Prince, Haiti, as a 9 shortly before the recent earthquake. The Board of Building Standards in Ohio manages one of the best systems of code enforcement available today, with high standards for building official certifications that involve stringent experience requirements in addition to the ICC testing, and State-mandated continuing education. We were the first in the country to have a Building Code Academy, designed and manned by members of the Ohio Building Officials Association and now managed by the ICC. In spite of all of these ground-breaking achievements, we in Ohio receive terrible scores on your assessments largely because our system of the review and adoption of the codes keeps us on editions of the code slightly older than some other jurisdictions. What is the reason, one might ask, for the updating of the code edition every three years. How good can an electrical code get, for instance, that has been in existence since 1900. The logical answers to these questions often have nothing to do with safety, but address new products in the marketplace and new technology that has become available. It might also have to do with the simple selling of new books each year in order for the code organizations to stay in business. Whatever the reason(s) might be, they are not sufficient cause to rate dozens, or even hundreds, of building departments poorly or to possibly cause a citizen to have to pay higher insurance rates.

The basic system and criteria that you use to do your ratings is seriously flawed and results in unnecessary stress and embarrassment in front of our legislative bodies and our citizens. I am going to use every opportunity that presents itself to lobby the OBBS and my colleagues in the Ohio Building Officials Association and the Building Officials Conference of Northeast Ohio for an end to the senseless and meaningless visits and assessments by ISO in our Ohio Departments. I intend to copy this letter to every building official in my mailing list to encourage them to join my boycott of this flawed program. For my own part, I can report that ISO will never visit a department under my direction again. I hope that things can be changed to correct these conditions to make the system useful and sensible again.

#### What is ISO? (follow the links for more information)

ISO stands for Insurance Services Office, Inc. (not International Organization for Standardization as in ISO 9000)

ISO is a private, for-profit company that provides "statistical, actuarial, underwriting, and claims data; policy language; information about specific locations; fraud-identification tools; consulting services; and information for marketing, loss control, and premium audit."

ISO is an advisory organization, and insurers may use the information, modify it, or not use it, as they see fit.

#### **Building Departments and ISO** (quoted from ISO's website)

"The Building Code Effectiveness Grading Schedule (BCEGS®) assesses the building codes in effect in a particular community and how the community enforces its building codes, with special emphasis on mitigation of losses from natural hazards." [empahsis added]

"The concept is simple: municipalities with well-enforced, up-to-date codes should demonstrate better loss experience, and insurance rates can reflect that. The prospect of lessening catastrophe-related damage and ultimately lowering insurance costs provides an incentive for communities to enforce their building codes rigorously — especially as they relate to windstorm and earthquake damage." [empahsis added]

"The anticipated upshot: safer buildings, less damage, and lower insured losses from catastrophes." [empahsis added]


"ISO develops advisory rating credits that apply to ranges of BCEGS classifications (1-3, 4-7, 8-9, 10). ISO gives insurers BCEGS classifications, BCEGS advisory credits, and related underwriting information."


