### Paul's Update

We had another record month in January with over 200 individuals attending our monthly meeting! We continue to be the largest OBOA chapter in the state. Our local chapter comprises more than a third of all the members across Ohio among the seven chapters. Due to the large number of attendees, we are continuing to work on the sign-in process for our meetings. The Board of Building Standards has required us to have members sign-in at the beginning of the meeting and not receive certificates until the member signs out at the end of the presentation. We are breaking up the registration sign-in/out sheets alphabetically so members are not congregating in one area of the table. All members from the City of Cleveland are located on their own sign-up sheet. We will continue to "fine tune" to sign-in process so it works in an effective manner. At the conclusion of each meeting, please take time to look around your table and the area and throw away any trash. We have a nice facility to hold our venues and it is only right that we leave the room in the condition we receive it.

At the January meeting of the Ohio Board of Building Standards, the Board moved the adoption of the new cycle of codes for Ohio Building, Mechanical and Plumbing out of the public hearing process and to be filed with the Joint Committee on Agency Rule Review (JCARR). No effective date of the new codes has been established but it is anticipated to occur during the middle part of this year.

If you are planning to attend the OBOA/COCOA Joint Conference in March, you only have a few more days to receive the early bird registration fee. After February 11<sup>th</sup>, the price for the conference will increase.

The OBOA Angle is a quarterly publication that is distributed to all members. They are continually looking for news articles for the publication. If you would like to highlight something your building department is doing or a new procedures that could help other jurisdictions, please consider sharing with others from around the state. Writing an article is a nice way to share new ideas and procedures with other departments from around the state. Being able to communicate what is working with other code officials helps to increase our effectiveness as a whole.
