## Building Officials Symposium on May 12<sup>th</sup> & 13<sup>th</sup>, 2011

I want to take this opportunity to invite all our members to the Building Officials Symposium that will be sponsored by BOCONEO on May 12<sup>th</sup> and 13<sup>th</sup>, 2011. It will be held at the Normandy Party Center in Wickliffe, Ohio.

Six hours of BBS-approved continuing education classes will be provided on each day that is <u>all</u> approved across the board for every certification.

On Thursday, May 12<sup>th</sup>, Steve Regoli, Jan Sokolnicki and Rob Johnson of the BBS will conduct three separate classes during the day that include a 3-hour Chapter 1-Administration class, 2-hours on Building and Fire Departments Joined at the Hip, and a 1-hour Building Department Investigations class.

On Friday, Bob Schutz will conduct a Legal Aspects of Code Administration class for 3 hours in the morning, followed by a great, 3-hour class on Communications for Code Officials class that was developed by Alan Rhea of Cleveland State University especially for BOCONEO.

The Friday classes are also well-suited for your clerical personnel, since they often handle questions on legal matters and deal with difficult contractors and citizens. All OBOA or BOCONEO members (and your clerical employees) are invited to attend at the cost of \$80 per day, which also includes continental breakfast and lunch.

Paul's Vpdate

The Golden Rule states that "one should treat others as one would like others to treat oneself." Utilizing this idea for dealing with the public lends itself to great customer service. The following ideas can help reach this goal:

Focus not so much on what the customer has to do to gain expedient service but what the jurisdiction can do to give the customer expedient service.

Treat everyone as a customer – applicants, property owners adjacent to a project, other departments and staff, outside agencies and other jurisdictions.

Remember that the customer doesn't know all the rules and regulations – many are occasional users. Jurisdiction staff is the professionals who work with the rules every day and even they can be unclear of proper application on occasion. Help customers navigate through the system.

Inform customers of options, whether it's how to comply or how to appeal.

Many customers' first impression of a jurisdiction is over the telephone. Staff answering the telephones need to be adequately trained to answer calls quickly, professionally and accurately. Callers shouldn't be put on hold without talking to someone first.

Get the customer to the right person the first time. Develop a reference guide or service directory for use by staff to aid in directing customers and routing calls to the specific staff that can help them rather than just referring the customer to a department.

Keep reception staff informed of current issues so they can provide accurate information to callers.



It's not often due to the nature of our business, but it is nice to receive a call from a resident to let me know that staff treated them with respect and that their concerns were properly addressed. When I hear that, I know our department has implemented good customer service.

Technically Speaking...

April 2011

This month we began using the online services of Constant Contact for registrations of the April ICC sponsored class, as well as the May Building Officials Symposium. This service allows us to take reservations and also process payments with credit cards. We knew there would be a few glitches to work out, and for the most part, they were minimized. For those that ran into small problems, we apologize, but rest assured we are working to make the needed corrections so they do not happen again. ## A new website format is just around the corner.
