Paul's Vpdate

I have written in many of my past articles about the need for strong customer service when delivering our services to the community. Of all the levels of government (local, state and federal), the local establishments get the most contact with the residents on a daily basis. With the downturn in the economy over the past few years, residents losing their jobs, contractors trying a make an extra buck by forgoing permits and people in general not being happy with government; this has put a lot of stress on the employees at the level of the local government. It is very convenient for an angry individual to show up at the permit counter and vent their frustrations.

Many building departments have been affected by being understaffed, pay freezes, cut in hourly rates, and furlough days. Residents and council people still feel we have the means to maintain the same level of service even though we are working with less and it doesn't look like things will change anytime soon. With the State of Ohio eliminating the local government fund and estate tax, jurisdictions are going to feel even more burdened going into 2012 and 2013.

With all these burdens placed on our departments and dealing with a public that doesn't fully understand our constraints on a daily basis, we still have to find it in us to give service with a smile. I can tell you it is not always easy to control your temper given this environment but then each week I also find that as long as I have helped a resident, educated a contractor and solved a code issue on a job site, I am doing my job. If put in a difficult situation, we sometimes have to step back and understand that the anger is not necessarily personal but a result of the pressure that everyone is feeling in this economy. If you are in this position, review the situation, talk professionally through the issues and try to look for a solution to the problem that is in front of you. If you find that you are holding your ground, not listening, or raising your voice; you will only increase the tension in the situation. We will not be able to make every resident or contractor happy but if we approach every problem with a level head, talk through the issues and remain calm, I am sure we can diffuse the anger and find an answer to the problem. The key is professionalism and to remember not to take the situation personal. In most cases you will find that once the anger is removed, people will listen. We are in tough times and quite often put in tough positions but they always say, "cooler heads will prevail." Good luck and keep up with what you do on a daily basis. We do make a difference!

1) Notches in solid lumber joists, rafters and beams shall not exceed one-quarter of the depth of the member.

True: Go to R802.10.1 – Word number 6 False: Go to R802.10.1 – Word number 4

2) For other than black steel pipe, exposed piping shall be identified by a red label marked "Gas" in black letters.

True: Go to M1408.2 – Word number 1 False: Go to M1408.2 – Word number 14

3) Pressurized expansion tanks shall be capable of withstanding a hydrostatic test pressure of two and one-half times the allowable working pressure of the system.

True: Go to R404.2.5 – Word number 2 False: Go to R404.2.5 – Word number 6

4) Any glazing material is permitted to be installed without screening in the sloped areas of greenhouses, provided the greenhouse height at the ridge does not exceed 18 feet.

5) Floor joists with spans that exceed 12 feet shall have the bottom flanges laterally braced in accordance with one of the following: Gypsum board or continuous steel strapping.
