Past President Ray Sack Wickliffe, Ohio Another issue that we must continue to work on is consistency among the departments. We all follow the same code and BOCONEO provides education and roundtables with the hope that we will come away from the meetings with some consensus on particular issues.

One issue I want to raise deals with detached garages. On many of my footer inspections for these garages, I request that the footer is continuous on all four sides. Many contractors question me and ask why do I insist on a footer along the side of the garage that only has the overhead door. I always have the same discussion about the footer being continuous on all sides. I have heard that in some communities, they are not requiring the footer along the front of the garage. To clear this up, I sent the following question to the ICC:

Question: In a detached garage, based on section R403.1, I require that the footing is on all four sides of the structure. I have raised this issue with other inspectors in our area that only require the footer on three sides of the structure stating that no footer is required on the front side of the garage because there is only the overhead door with a "wing wall" on each side. I believe that in order to make the footer "whole", it must extend on all four sides. However minimal, I recognize that the wall of the garage with the overhead door is still taking on a load. Is my assumption correct?

ICC Response: Yes. The prescriptive designs in the IRC are based on a continuous footing/foundation for all exterior walls. A garage door is an opening in an exterior wall and the footing is required to be continuous in accordance with Section R403.1. A non-continuous footing would require an engineered design in accordance with Section R301.1.3. Also, the portal frame Figures R602.10.3.3, R602.10.3.4 and R602.10.4.1.1 require a continuous footing at the garage door.
