During Building Safety Month in May, members from BOCONEO took our message to the public with a display at Home Depot in Steelyard Commons. This enabled us to pass out material showing building safety ideas and tips. An article also appeared in the Cleveland Plain Dealer discussing careers in code enforcement.

Our board has been committed to quality education and I strongly believe that we have provided education to allow members to meet their requirements for continuing education credit. First Vice Presidents Report

CHAPTER

BOCONEO's tagline is "Where education is at the center of our organization." In keeping with this focus, BOCONEO continues to offer continuing education and keeps the membership up-to-date with the State of Ohio changes to the codes and laws. Each month the membership can obtain between 1-4 credits from the presentations and attend either an electrical or plumbing roundtable. The purpose of the roundtables is to bring understanding and standardization between the building departments in the Northeast Ohio region.

At this year's BOCONEO Code Institute the main speakers were Ralph Dolence and Jerry Flanik. Ralph Dolence presented the causes in many forensic cases that have resulted in property damages and deaths, and Jerry Flanik addressed the required electrical codes.

The State of Ohio BBS formed a committee to review the requirements for Building Department Personnel. Mike Gero provided a response to OBOA, and Jerry and I forwarded an analysis in support of these changes.

At times many do not think of those in the Building Department as officials serving the public and providing safety, and there are many that are not familiar with the procedures and code requirements. This year Paul Kowalczyk led BOCONEO in an outreach program to reach out to the public and change the public's perception of Building Officials.

Each year BOCONEO offers the membership an opportunity to unwind by golfing, but not without a cause. In this slower economy the proceeds that are collected went to scholarships that assist students in their education pursuits.

The State of Ohio is reevaluating their involvement and support of the Annual State Conference. As a result, the chapters are discussing centralizing it for next year. Next year, BOCONEO will be involved with annual conference and hopes to sponsor another local code institute.

Second Vice President's Report

It has been a pleasure to work with our membership and the BOCONEO Board of Directors over the past year. I am pleased to provide this annual report to the BOCONEO Board of Directors. It has been one year now since the 2011 OBC went into effect, and more recently, there are only a couple of months left until the new 2013 RCO will be in effect for enforcement throughout Ohio. It becomes quite evident that all of us must continue our education to be effective in our chosen careers. Throughout the first quarter of this year, the Board of Directors worked on scheduling our monthly educational classes for the year. Due to the cancellation of OBBS meetings earlier in the year, it was not possible to get many new courses approved for a spring BOCONEO Educational Institute. Consequently, we discussed developing other interesting courses that we could provide to the membership in addition to our monthly educational offerings.

One such course that was developed was titled Case Studies for Proper Plan Review & Inspection to Avoid Disaster! Mr. Ralph Dolence (nationally recognized forensic electrical and fire investigator) and I developed this 6-hour (one-day) course in late February (presented on June 15, 2012). The goal was to provide both building and fire officials with a clear explanation and understanding of selected OBC, RCO and NEC code sections as they relate to actual cases that involved electrocutions, fires, incorrect design, and faulty installation of electrical systems. Therefore, I am recommending that our Board of Directors, over the coming year, continue to spearhead the development and delivery of even more "effective" education in the areas of building, electrical, fire protection, mechanical and plumbing that will benefit our members.

The recession over the past several years has caused high unemployment rates with more and more people dissatisfied with government in general. Accordingly, many building departments have suffered severe budget cuts resulting in staff layoffs, little or no education funding, and trying to do "much" more with less. Upon speaking to other building officials throughout northeast Ohio that were trying to hire certified building department staff, they echoed the need to revise our current OBBS certification requirement matrix in an effort to help supply the demand for qualified people in our certified building departments as the economy gets better. The Board of Directors must stay involved in the upcoming year regarding potential changes to the OBBS certification requirement matrix and provide feedback to the membership.

In September, Paul Kowalczyk, Dave Smith and Jerry Flanik represented BOCONEO at an ACCA (Air Conditioning Contractors of America) discussion meeting with ACCA members from Akron, Canton, and Greater Cleveland along with building officials from surrounding areas. The focus was to discuss new mechanical code changes regarding the 2011 OMC and upcoming changes in the 2013 RCO. Initially, the questions centered on technical changes such as the new 2011 OMC mechanical ventilation requirements according to Section 403 and new dryer exhaust changes in the 2013 RCO. I briefly discussed the difference between the 2007 OMC mechanical ventilation requirements and 2011 OMC mechanical ventilation requirements. Additionally, I stressed the importance of a properly designed mechanical ventilation system to bring the correct amount of outdoor air into the air distribution system and effectively move it the across the breathing zone (See BOCONEO Newsletters for March and April regarding more details on the 2011 OMC mechanical ventilation requirements).

During the discussion a few contractors stated that certain building departments do not enforce the codes uniformly throughout our region. The following example was given by a mechanical contractor attending the meeting: "Recently my company replaced an existing air conditioning condensing unit and the inspector required that a new GFCI receptacle must be installed within 25 feet of the replaced condenser." The consensus among the panel of building officials was only to require the receptacle (NEC 210.63) for a new installation of an air conditioning system, and not the replacement of an "existing" piece of equipment. In order to create uniformity within our jurisdictions, I have recommended to the Board of Directors that we assemble a small group of building officials to initially work on developing cohesive uniformity regarding our upcoming 2013 RCO.

The goal is to first, build uniformity among the 2013 RCO Focus Group. Secondly, promote and advocate uniformity throughout our BOCONEO jurisdictions. Thirdly, build a uniform line of communication between everyone involved in the building process. Lastly, in the upcoming year, we should be able to use this process as a model to build uniformity in other areas that need to be studied. Our ultimate goal is for every jurisdiction to provide excellent service and uniform enforcement of building codes and standards.



I am looking forward to working with the BOCONEO Board of Directors and the membership in 2013 to keep education as a top priority, which in turn will continue to empower the members for their success in the future.

Boconeo 2012 Education Report
