Further, notice is hereby given that a vote will be held to amend ARTICLE III, Section 3.09 of the Bylaws of BOCONEO. Article III, Section 3.09 – Dues is being proposed to be amended as follows:

ARTICLE III – MEMBERSHIP STATUS

Section 3.09 – Dues

Any change in dues shall be recommended by the Board of Directors to the general membership at the regular meeting prior to the Annual Business Meeting. Such recommendation shall be included in the mailing to members prior to the Annual Business Meeting. A two-thirds majority of voting members shall be required to adopt such recommendation, and the minutes shall be appended to the by-laws. Such vote shall be taken at the Annual Business Meeting.

- (A) For Regular and Associate Membership ~~\$80.00~~ **\$100.00** per year includes OBOA joint membership.
- (B) For Cooperative Membership ~~\$95.00~~ **\$100.00** per year. ~~\$90.00 per year if a Member of a professional, trade, or construction chapter.~~ Includes OBOA joint membership.
- (C) Honorary Members are exempt from paying dues. Includes OBOA joint membership.
- (D) Retired Members are exempt from paying dues. Includes OBOA joint membership. **A meal cost will be charged for each meeting and the cost will be set by the Executive Board.**
- (E) Student Membership \$25.00 per year. BOCONEO membership only.
- (F) Dues shall be payable immediately upon acceptance for membership and thereafter upon the first day of January of each year. Dues paid by new members joining the Conference on or after ~~October~~ **November** 1st, will apply to the forthcoming year
- (G) **Non-members may attend any meeting at a cost to be determined by the Executive Board.**

First Vice President's Report

During the past year.....

I have had the pleasure to work with our membership and the BOCONEO Board of Directors over the past year. Can you believe another year is coming to an end? Additionally, it has been almost one year since the 2013 RCO went into effect.

Around this time last year, we assembled a small group of building officials and plans examiners to focus on the changes regarding the new 2013 RCO. During the first two quarters of 2013 we met several times to evaluate some of the more difficult areas of the new code. Certain areas of the 2013 RCO were split up between the group members to focus on and "thoroughly" research changes from the 2006 RCO. The goal of each member was to evaluate how the new changes will effect plan review from submittal to the issuance of approvals, as well as providing feedback on how field inspections will be handled based upon the new changes.

Some of the outcomes included local consistency (keeps getting better) aimed at the enforcement of the 2013 RCO, the creation of the "2013 (RCO) Systems Description Form" and "2013 (RCO) Energy Compliance Declaration Form". Owner/owner agents can clearly specify the building services and energy information on these forms. The forms will facilitate faster turn-around time for plan reviews and approvals regarding electrical, mechanical, fuel gas, plumbing, and energy compliance options. These forms are available on our BOCONEO website and have been integrated into "applications for plan approval" in several jurisdictions throughout our area. Additionally, we have gone over the details concerning the new wall bracing requirements in the 2013 RCO (Section 602.10).

My goal for 2014 is to continue building consistency throughout our jurisdictions.
