# First Vice President's Report

The Ohio Board of Building Standards has determined a local adopted ordinance from several northeast Ohio communities regarding the exclusive use of photoelectric smoke alarms is contrary to the Ohio Building Code and the Residential Code of Ohio.

Revised Code 3781.01(A) provides that local governing authorities may not adopt regulations in conflict with the code. Also, mechanisms are in place for local municipalities to submit changes to the code. Implemented changes then become part of the state wide code for consistency and uniformity.

As for the photoelectric smoke alarm, Section 907.2.11 of the Ohio Building Code and Section 314.1 of the Residential Code of Ohio requires the installation of smoke alarms that comply with UL 217. Although a photoelectric smoke alarm meets this standard, so does the ionization type of alarm. As such, the ordinances from these municipalities requiring only photoelectric type smoke alarms have been deemed contrary to the code. Not all alarms of either type conform to UL 217. It is important to check your listing.
