We've continued to adhere to our commitment to continuing education by offering insightful and pertinent classes for our members every educational month.


We continue to offer plumbing and electrical roundtables, so that folks with those certifications are easily able to obtain plumbing and electrical hours for recertification.

## Treasurer's Report

The financial position of BOCONEO remains strong. We must continue to be active in recruiting new members while retaining existing members. Our monthly meetings and periodic code classes continue to be the most economical source of continuing education in Ohio. Please continue to support our organization by attendance at the code classes and with your annual membership dues.

2014 compared to 2015 saw a slight decrease in revenue of approximately \$2,500 attributable to a decrease in membership. Most notable was a decrease in membership registrations from the City of Cleveland.

Expenses year to year have remained almost the same, with slightly higher meal costs and onetime expense for improvements to the Normandy sound system in 2015 offset by the timing of an insurance payment which will be made later this year.

The current general checking account balance is \$17,485. Scholarship account balance is \$5,857. Certificates of Deposit total \$24,015. This for total of \$47,357.
