The schedule includes hearings on proposed changes to the codes that serve as the basis for Ohio's codes, including: International Building Code (IBC) egress, fire safety and general provisions; International Fire Code (IFC); International Fuel Gas Code (IFGC); International Mechanical Code (IMC); International Plumbing Code (IPC); and International Residential Code (IRC) mechanical and plumbing provisions. Approved changes resulting from the 2018/2019 ICC code cycle will be incorporated into the 2021 IBC, IPC, IMC and IRC which will be basis for the next full, non-residential building code update in Ohio. The Committee Action Hearings are free to attend.

### Fire Marshall's Report

The 2017 Ohio Fire Code, based largely on the 2015 IFC was adopted by the State Fire Marshal last December. Several new sections were added in this revision that as building officials, inspectors and design professionals may be of interest and significance, 3 of which I will address here.

Chapter 3, paragraph 320 entitled "Mobile Food Units" now applies to "All mobile food units operated in this state". This paragraph contains some comprehensive and specific requirements regarding not only operational and fire protection concerns, but also wiring, fuel gas piping, and LP gas tank installation. Specific standards are referenced including NFPA 58 and NFPA 70.

Chapter 53, paragraph 5307 deals specifically with carbon dioxide systems used for beverage dispensing. This new section requires either mechanical ventilation and/or an emergency alarm system for CO2 systems with an aggregate capacity exceeding 100 lbs. and references the Mechanical Code.

Your fire code officials may seek your assistance with the application of these requirements or may reference certain sections as they may apply in the plan review process.

In Chapter 9 paragraph 903, the requirement for the installation of fire sprinklers in certain types of occupancies differs significantly from what has been adopted in the 2017 Ohio Building Code. The difference between the two codes lies with the area thresholds that trigger the requirement for sprinklers protecting spaces where upholstered furniture and mattresses are manufactured, stored and displayed for sale.

### Fire Marshall's Report

The Ohio Fire Code language is taken verbatim from the 2015 ICC requiring sprinklers in Groups F-1 and S-1 used for the fabrication and storage of upholstered furniture and mattresses respectively where the occupancies used exceed 2,500 square feet, and in Group M where the occupancy used exceeds 5,000 square feet.

In comparison, the 2017 building code sets the threshold at 8,000 square feet for all three groups. The requirement in the IFC and OFC was implemented as a direct result of the aftermath of the Super Sofa fire in Charleston, SC on June 18th 2007 where nine firefighters lost their lives, mostly attributed to a condition known as flashover.

Fire and building officials will need to work together closely through the plan review and construction processes when dealing with the manufacture, storage, display and sale of these products. It is my hope we can work together to eventually align both codes for the greater good of protecting the public and our fire suppression personnel across the state.
