The State Fire Marshal is in the process of updating the 2017 Ohio Fire Code. You can find information regarding the process and how to participate at the following link:

The following is a synopsis of the information provided on the SFM's website: **2017 OHIO FIRE CODE – ERRATA PACKAGE**

The SFM has filed an errata package with the Joint Committee on Agency Rule Review (JCARR) to correct filing and typographical errors in specific rules. OFC paragraphs 320 (regarding mobile food units) and 906.1 (regarding portable fire extinguishers) are also being amended.

The SFM will host a public hearing on the rules on Monday, Nov. 19, 2018, at 9:30 a.m. at the Division of State Fire Marshal, 8895 E. Main Street, Reynoldsburg, OH 43068. To view a red-lined copy of the rules being amended, please click here.

To submit a comment or provide testimony regarding the proposed rules, you may appear at the SFM public hearing on Nov. 19, or you may submit written testimony to the SFM on or before 5 p.m. Nov. 19. Written testimony may be submitted via hand delivery, mail, facsimile, or e-mail to:

Pulse Night Club Shooting

The June 12, 2016, Pulse shooting in Orlando, Fla., left 50 people dead, including the gunman. Carlos Tavarez and Joshua Granada were the first paramedics to arrive at the Pulse nightclub after a gunman opened fire in the early that morning. Over the next few hours they transported 13 people with life-threatening injuries to the Orlando Regional Medical Center (ORMC).
