Special announcement regarding the May class: The May class will be sponsored by the BBS. The class is the new RCO updates and will be presented by BOCONEO's own Jerry Flanik. The BBS will be handling the registration and certificates. The class will start at 10 a.m., run until noon when we will break for lunch and then start back up at 1 p.m. and end at 3 p.m. *Please make note of the time changes!*

The Board of Building Standards adopted an update to the Residential Code of Ohio (RCO) based on the 2018 International Residential Code with Ohio changes effective July 1, 2019, including adoption of the 2018 International Energy Conservation Code (IECC) for residential projects. In preparation of the new code, the Board has partnered with the International Code Council (ICC) to present in-person training on the new residential and residential energy codes. The in-person training are open to building department personnel and the public, including contractors, builders and design professionals*. There is no cost to attend and all attendees will receive copies of the ICC publications 2018 Residential Code Essentials and/or 2018 Energy Code Essentials.

This course is approved for 4 hours of continuing education for all Board-issued certifications. The course is not mandatory to renew your residential certifications; however, attendance is strongly encouraged to familiarize yourself with the new code.

Registration is required to attend these events.

Past President James Decker Mentor **New certification requirements** - Everyone should have received an email from the BBS announcing that the new certification rules have gone into effect on April 1, 2019. Check the memo for all of the specific changes. One of the new rules is for renewals submitted on or after January 1, 2020, all certification holders are now required to take **3 hours of code administration instruction**, **3 hours of existing buildings instruction**, and **1 hour in ethics** every renewal period. The Board will work to identify courses meeting these requirements, and to ensure that opportunities are provided for all certified personnel to obtain the required continuing education. BOCONEO is looking into providing these required classes for the membership.

Please remember, if you did not receive your class certificate within 10 days of the meeting, you must let me know right away. The most common reason that you did not receive one is that you were not scanned into the class roster list. Please be sure to scan in at each meeting. If you are not on the list, we will not be able to supply you with the certificate.

The planning and scheduling of the continuing education classes for 2019 is just about completed. However, 2020 will be just around the corner! Second Vice President's Report

The code panel made changes to the language for section 210.52(G)(1), dwelling unit receptacle outlets in detached & attached garages. The changes will eliminate the interpretation of one receptacle outlet being shared by two adjacent spaces. The NEC 2014 language "at least one receptacle outlet shall be installed for each car space"...2017 language "at least one receptacle outlet shall be installed IN each vehicle bay." The term vehicle recognizes the fact that other vehicles such as pickup trucks, sports utility vehicles, etc. could be parked in a dwelling unit garage as well as a car.

The height remains as not more than 5 ½ feet above the floor. The revision is intended to ensure that a receptacle outlet is reasonably close to where it is needed in the garage area thus diminish the use of an extension cord.
